

**ORDER OF COUNTY COMMISSION

On the 7th day of April, the following, among other proceedings, were had by the County Commission of Bollinger County:

The Bollinger County Commission met today pursuant to adjournment of March 31st, 2025 with the following officers and members, Leo Arnzen, Presiding Commissioner, Travis Benfield and Chad Hulvey, Associate Commissioner, Megan Hill, County Clerk, for a short period then County Clerk left for election, Deputy Clerk Amy Ennis finished the meeting. Meeting called to order by Leo Arnzen, Presiding Commissioner at 8:00 a.m.

Commission reviewed minutes from the March 31st, 2025 commission meetings. Leo Arnzen made a motion to approve minutes as read, second by Chad Hulvey. A vote was taken results are as follows: Leo Arnzen yes, Chad Hulvey yes, Travis Benfield yes, all were in favor, motion carried.

Ronda Eftink, Assessor, submitted 2024 Real Property Order for

Daniel Winningham with the Banner Press observed the meeting.

Brad Gregg with the R&B department met with the commission to discuss problems with the county roads.

Ronda Elfrink, Assessor; Mike Henson, Field Review; Tucker Schneider, Field Review met with the commission to discuss the damages from recent weather events within the county. The March 14th tornado affected 14 parcels. Residences that were effected will be removed from 2025 taxes. The outbuildings will be removed in 2026. April 2nd tornado affected 6 parcels that they have found so far, they are still waiting for flood waters to recede before completing an assessment.

Kevin Cooper, Emergency Management, met with the commission to discuss the progress on DR4741 – still waiting on movers' account to be setup so the county can be paid. Discussed 524 bridge- Made contact with MODOt and have sent the assessment; waiting on the engineers' input.

Garrett and Cassie Garner met with the commission to discuss about adding a temporary crossing on 710, the commissioners will be getting the temporary fixed immediately – while also working to get the bridge fixed.

Michael Pollard, Annie Criddle, and Shawn Huffman with Dille Pollard met with the commission to discuss the resolution with the sales tax. Michael discussed that he would like to get ahold of the reps to confirm resolution has been attached to a bill. Next step in the process will be meeting with the elected officials to discuss the current needs of each office.

Donnia Beshar with Bollinger County Abstract and Title met with the commission to ask the county to deed back property at SW Quarter of NE Quarter Section 33 Township 31 Range 10 72X36, which is a cemetery that was deed to the county in 1881. A vote was taken, results are as follows:
