On the 15<sup>th</sup> day of September, the following, among other proceedings, were had by the County Commission of Bollinger County:

The Bollinger County Commission met today pursuant to adjournment of September 8<sup>th</sup>, 2025 with the following officers and members, Leo Arnzen, Presiding Commissioner, Chad Hulvey and Travis Benfield, Associate Commissioner, Megan Hill, County Clerk. Meeting called to order by Leo Arnzen, Presiding Commissioner, at 8:00 a.m.

Commission reviewed minutes from the September 8<sup>th</sup>, 2025 commission meetings. Leo Arnzen made a motion to approve minutes as read, second by Chad Hulvey. A vote was taken results are as follows: Leo Arnzen yes, Chad Hulvey yes, Travis Benfield, yes, all were in favor, motion carried.

Brad Gregg, Road & Bridge Supervisor met with commission to discuss general county road concerns.
