

**ORDER OF COUNTY COMMISSION
STATE OF MISSOURI
COUNTY OF BOLLINGER**

On the 18th day of August, the following, among other proceedings, were had by the County Commission of Bollinger County:

The Bollinger County Commission met today pursuant to adjournment of August 11th, 2025 with the following officers and members, Leo Arnzen, Presiding Commissioner, Chad Hulvey and Travis Benfield, Associate Commissioner, Megan Hill, County Clerk. Meeting called to order by Leo Arnzen, Presiding Commissioner, at 8:00 a.m.

Commission reviewed minutes from the August 11th, 2025 commission meetings. Leo Arnzen made a motion to approve minutes as read, second by Chad Hulvey. A vote was taken results are as follows: Leo Arnzen yes, Chad Hulvey yes, Travis Benfield, yes, all were in favor, motion carried.

Nonie Cowell, Collector, met with commission to have the Commission accept or reject the Senior Service Tax applications submitted. She currently has 700 accepted applications.

Brad Gregg, Road & Bridge Supervisor met with commission to discuss general county road concerns.

Berkley Lane needs attention. It was later determined by commission that Berkley Lane in Zalma is a private lane that will need to be maintained by the individuals.

Representative Tony Harbison met with the commission to discuss recent activity in the county regarding Corridor I66 and the Flag being placed in Patton round-a-bout. Rep. Tony Harbison stated that he went to a meeting in Jefferson City to discuss receiving his support for the I-66 route but after discussion, he will not be giving the support for this project. He stated the group currently has no funding for the project, no accurate plans, and no environmental studies on land. At this time, he feels the project is years away and will not support a project. He also mentions that the Patton Flag in the round-a-bout will not be approved through MoDot due to safety concerns of vehicles hitting the flag pole. Rep Harbison said he spoke with Mark Croarkin Assistant Chief Engineer with MoDot and the Flag would not be approved.

John McCarty with Arch Brokage Inc spoke to the commissioners about switching insurance companies to achieve a cheaper rate. A bid will be placed at a later time.

Megan Hill, County Clerk asked to go into closed session at 10:56 a.m. per RSMo 610.021(1), motion made by Leo Arnzen, second by Chad Hulvey. A vote was taken results are as follows: Leo Arnzen yes, Travis Benfield, yes, Chad Hulvey yes, all were in favor motion carried. At 11:06 am. Leo Arnzen asked for a motion to return to open session, motion made by Chad Hulvey, second by Leo Arnzen. A vote was taken and results are as follows: Leo Arnzen, yes, Travis Benfield, yes, Chad Hulvey, yes.

Stash Petton, Sheriff, and Nick Becker met with the commission regarding Charter Communication. The commission discussed with the Sheriff what can be done with Charter communication about the damage they have done with our county roads. Sheriff discussed that the best thing would be to contact the Attorney because the county could not legally make Charter leave.

The commission did contact the County Attorney to advise the county that at this current time, the only thing that could be done would be gather the damages done and he would look at it and look at different options.

EPD Renewables Project Director met with the commission to discuss the process regarding the Solar farm placed here in Bollinger County.
